# 71 Potential Leading Health Indicators for Healthy Alaskans 2020: Documenting Progress Towards 25 LHIs

The purpose of this report is to document the data and information provided to the Healthy Alaskans 2020 (HA 2020) Advisory Team members to inform their deliberations regarding recommendations for the 25 Leading Health Indicators (LHIs) that would be the focus of the Healthy Alaskans 2020 initiative. The data contained in this document are those presented to the Advisory Team April 1-2, 2013. Note that the data presented here do not reflect data revisions that routinely occur with each dataset, and that because of this there will be discrepencies between this document and other HA 2020 reports, which use the most current data.

This first section (pages 1-7) lists out all 71 Potential Leading Health Indicators (PLHIs) that were considered, the HA 2020 objective under which each falls, and notes on the 25 indicators that moved forward to become Alaska's LHIs (highlighted in light blue). Subsequent pages, labeled by PLHI number, display trend data and decribe data sources and technical notes for each. Numbering of the PLHIs and LHIs does not denote rank or priority.







### 4 Rate of alcohol related mortality (per 100,000 population)









### 7 Rate of (overall) cancer incidence (per 100,000 population)















# Percentage of adolescents (high school students grades 9-12) who meet criteria for Obesity (age- and sex-specific body mass index >95th percentile)







### 13 Incidence rate of low birth weight (birth less than 2500 grams as percent of live births)





### 14 Incidence rate of preterm births (<37 weeks gestation as a percent of live births)









# 17 Percentage of high school students who felt so sad or hopeless every day for 2 weeks or more in a row that they stopped doing some usual activities during the last 12 months







### 19 Percentage of high school students who have smoked cigarettes on one or more of the past 30 days











### 25 Percentage of high school students who engage in at least 60 minutes of physical activity a day, every day of the week







## 27 Percentage of adults (aged 18 years and older) who consume at least 5 daily servings of fruits and vegetables







## 29 Percentage of high school students who consume 1 or more sugar-sweetened beverage daily









## 32 Percentage of women who delivered a live birth who report use of alcohol during last 3 months of pregnancy









## 35 Percentage of high school students who took a prescription drug without a doctor's prescription one or more times during the past 30 days





## 36 Percentage of live births that occur as a result of an unintended pregnancy





## 37 Percentage of high school students who have never engaged in sexual intercourse





## 38 Percentage of sexually active high school students using a condom at last intercourse







## 40 Percentage of high school students who report riding at least once with a driver who had been drinking alcohol within the past 30 days





## 41 Percentage of adults aged 45 years and older who have had one or more falls in the past 12 months that caused an injury









## 44 Percentage of women delivering live births who received prenatal care beginning in first trimester of pregnancy







## 50 Percentage of adults aged 18 and older without health care coverage









## 56 Percentage of secondary schools (grades 6-12) in which students cannot purchase soda pop or fruit drinks that are not 100% juice





## 57 Percentage of Alaskan population served by community water systems with optimally fluoridated water





## 58 Percentage of 18-24 year olds with a high school diploma





## 59 Percentage of adults (25 years and older) who completed some college or higher education









## 62 Seasonally adjusted unemployment rate



## 63 Percentage of residents living below the federal poverty level - all ages (as defined for AK)





# 64 Percentage of housing units spending 30% or more of household income on housing costs (including housing units with a mortgage, housing units without a mortgage, and rental units)







## 68 Rate of forcible rape (per 100,000 population)





## 69 Percentage of mothers of 3 year olds who report that their child saw violence or abuse in person.





# Percentage of high school students who were ever hit, slapped, or physically hurt on purpose by their boyfriend or girlfriend during the past 12 months.




